**OF ALL THE WORK ESPERANCA CONDUCTS, NONE IS MORE DRAMATIC THAN THE EFFECT THE MEDICAL TEAMS (CONSISTING OF A MINIMUM OF A SURGEON, NURSE, AND ANESTHESIOLOGIST) HAVE ON THE LIVES OF THE FAMILIES SERVED THROUGH OUR VOLUNTEER SURGICAL MISSIONS. LAST YEAR, ESPERANCA SENT NINE VOLUNTEER SURGICAL TEAMS TO NICARAGUA AND PERU. THEY PERFORMED 2,416 SURGERIES AND CONSULTATIONS WITH AN IN-KIND VALUE OF \$2.02 MILLION.
